On the basis of your marks in the B.Ed. Entrance Examination held on 27<sup>th</sup> July, 2019, your name is proposed to appear before the Admission Committee. You are advised to appear before the admission committee along with below mentioned documents on 27<sup>th</sup> January, 2020 (Monday) at 11:00 AM at the IGNOU Regional Centre, 12 Arera Hills, Old Jail road, Bhopal – 462011, Madhya Pradesh positively. This offer is purely provisional and your admission will be made subject to fulfillment of eligibility criteria and verification of your certificates. In case you have applied under Other Backward Category (*Non Creamy Layer*), you have to bring your recent Income Certificate issued by competent authority, and only those candidates will be considered under OBC Category, whose annual income should not exceed 8.00 lakhs per annum and only central list should be followed. Mere qualifying the exams does not give the right for admission unless and until you fulfill the minimum eligibility criteria. The eligibility criteria for admission are as follows:

(a) Candidates with at least fifty percent marks either in the Bachelor's Degree and/or in the Master's Degree in Science/Social Sciences/Commerce/Humanity. Bachelor's in Engineering or Technology with specialization in Science and Mathematics with 55% marks or any other qualification equivalent thereto, are eligible for admission to the programme.

#### and

- (b) The following categories are eligible to be the students of B.Ed. (ODL):
  - (i) Trained in-service teachers in elementary education.
  - (ii) Candidates who have completed a NCTE recognized teacher education programme through **face-to-face mode**.

The reservation and relaxation of 5% marks in minimum eligibility will be provided to SC/ST/OBC (Non creamy layer)/PWD candidates as per the rules of the Central Government.

- d. Attested copy of the Gazette Notification reflecting the change of name/surname.
