Online B.Ed Admission Counseling (2024)

For Regional Centres Bhopal, Jabalpur , Nagpur & Raipur

(Nodal RC Bhopal)

The Admission Counselling Process for admission into the B.Ed programme of IGNOU (YR. 2024) will be conducted through Virtual Mode. For this admission cycle **IGNOU Regional Centre Bhopal** has been designated as the Nodal Regional Centre for coordinating the B.Ed admission activities for **Bhopal, Jabalpur, Nagpur & Raipur Regional Centres**.

A total number of **55 seats** will be filled on the basis of the marks obtained in the B.Ed entrance test on 07/01/2024 in accordance with the reservation policy laid down by the Government of India and as **per the directions received from Student Registration Division (SRD), IGNOU New Delhi**.

The Merit & Waiting Lists have been drawn for the initial scrutiny of the forms to ascertain the eligibility of the candidates as per the eligibility criteria mentioned in the B.Ed. Prospectus 2024. In case, a candidate does not fulfill the eligibility criteria, the candidature would be rejected by the Admission Committee with information to the candidate concerned. No further communication would be entertained in this regard.

The candidates shortlisted in the Merit List and the Waiting List are advised to keep the Programme fees ready, so as to make fee payment without any delay upon confirmation of admission (subject to their eligibility) and receipt of 'admission offer' from the nodal RC. The Link for depositing Programme fees will be made available on the admission portal after acceptance of the Offer of Admission.

In case of any discrepancy, the Committee may send mail seeking clarification/ response to the candidate concerned. The discrepancy must be resolved by the candidates immediately and within seven days by uploading the self attested scanned copy of the required documents and sending the same to the Nodal RC (kumudverma@ignou.ac.in and rcbhopal@ignou.ac.in) by Email also

Candidates may note that they are expected to possess the necessary qualifications supported by appropriate / relevant documents at the time of submitting application form for the entrance test and in case any shortlisted candidate is not able to resolve the discrepancy, within the stipulated time frame, he / she will not be given any extra time and the offer of admission would be extended to the next candidate in the Merit list. Following Guidelines may be noted in this regard:

- The merit list is purely provisional and subject to the verification of documents of eligibility criteria mentioned in IGNOU BED Prospectus 2024 and availability of seats. (मेरिट सूची पूरी तरह से अनंतिम है और इग्नू बीएड प्रॉस्पेक्टस 2024 में उल्लिखित पात्रता मानदंडों के दस्तावेजों के सत्यापन और सीटों की उपलब्धता के अधीन है।)

- Simultaneous Bachelor Degree Programme and Teacher Training Programme would not be considered admissible while processing B.Ed Applications. Accordingly the applicants who have completed their graduation degree and the DELED programme simultaneously or if a certain period of one programme coincides with the other programme, it will be regarded as doing “two programmes simultaneously” and they will not be considered eligible for admission to IGNOU’s B.Ed Programme. In view of this, the candidates who have the required percentage of marks at the PG level, but have completed the graduation degree (Regular/Open/ Private/ Distance education/ Non collegiate/ Correspondence) and the diploma (DELED) simultaneously also will not be considered as eligible.

(बी.एड. आवेदनों पर कार्रवाई करते समय एक साथ स्नातक डिग्री कार्यक्रम और शिक्षक प्रशिक्षण कार्यक्रम को स्वीकार्य नहीं माना जाएगा। तदनुसार , जिन आवेदकों ने अपनी स्नातक की डिग्री और डी.ई.एल.एड. कार्यक्रम एक साथ पूरा किया है या यदि एक कार्यक्रम की एक निश्चित अवधि दूसरे कार्यक्रम के साथ मेल खाती है , तो इसे “एक साथ दो कार्यक्रम” करने के रूप में माना जाएगा और उन्हें इग्नू के बी.एड. कार्यक्रम में प्रवेश के लिए योग्य नहीं माना जाएगा। इसके मद्देनजर , जिन उम्मीदवारों के पास पीजी स्तर पर आवश्यक प्रतिशत अंक हैं , लेकिन उन्होंने स्नातक की डिग्री (नियमित / मुक्त / निजी / दूरस्थ शिक्षा / गैर कॉलेजिएट / पत्राचार) और डिप्लोमा (डी.ई.एल.एड.) एक साथ पूरी की है, उन्हें भी योग्य नहीं माना जाएगा)

- All candidates up to 78 marks have been treated as under "General Category" in the first round of counseling. (77 अंक तक के सभी अभ्यर्थियों को प्रथम चरण की काउंसलिंग में के अंतर्गत माना गया "सामान्य श्रेणी" है।)
- The Waiting list may change as the candidates from waiting list may be elevated to merit list. Chance of admission will only be given subject to availability of vacant seats in respective category. (प्रतीक्षा सूची में बदलाव हो सकता है क्योंकि प्रतीक्षा सूची से उम्मीदवारों को मेरिट सूची में पदोन्नत किया जा सकता है। प्रवेश का मौका केवल संबंधित श्रेणी में रिक्त सीटों की उपलब्धता के अधीन दिया जाएगा।)
- The candidates claiming admission must possess a **face to face teacher education programme Mark sheet and Certificate recognized and approved by NCTE** . (प्रवेश का दावा करने वाले उम्मीदवारों के पास एनसीटीई (NCTE) द्वारा मान्यता प्राप्त और अनुमोदित फेस टू फेस शिक्षक शिक्षा कार्यक्रम की मार्कशीट और प्रमाण पत्र) होना चाहिए।)
- A Certificate of Recognition issued to the institution from where the candidate has completed face to face teacher training Programme, should be produced by the candidate while claiming admission. (जिस संस्थान से उम्मीदवार ने फेस टू फेस शिक्षक प्रशिक्षण कार्यक्रम पूरा किया है, वहां से जारी मान्यता का प्रमाण पत्र, प्रवेश का दावा करते समय उम्मीदवार द्वारा प्रस्तुत किया जाना चाहिए।)
- The reservation of **PH** candidates is horizontal and will be done as per norms (**minimum disability of 40%** as certified by recognized Medical authority). (PH उम्मीदवारों का आरक्षण क्षैतिज है और मानदंडों के अनुसार मान्यता प्राप्त चिकित्सा) प्राधिकरण द्वारा प्रमाणित न्यूनतम विकलांगता 40% है (किया जाएगा।)

- Candidates claiming admission under **OBC Non Creamy Layer (D4B)** category must submit **OBC Non Creamy Layer Certificate along with the Income Certificate.** (ओबीसी नॉन क्रीमी लेयर)OBC-NCL) श्रेणी के तहत प्रवेश का दावा करने वाले उम्मीदवारों को आय प्रमाण पत्र (Income Certificate) के साथ ओबीसी नॉन क्रीमी लेयर)OBC-NCL) प्रमाण पत्र प्रस्तुत करना होगा।)
- The **Income Certificate, not older than 3 years**, should be in the format as given in the Student Handbook and Prospectus of the B.Ed Programme. (आय प्रमाण पत्र, 3 वर्ष से अधिक पुराना नहीं होना चाहिए, तथा बी. कार्यक्रम की छात्र एड.पुस्तिका और विवरणिका में दिए गए प्रारूप में होना चाहिए।)
 - The **annual income** of candidates under OBC (Non Creamy Layer) **should not exceed Rs. 8.00 lakhs per annum .** (ओबीसी के तहत (गैर क्रीमी लेयर) उम्मीदवारों की वार्षिक आय 8.00 लाख रुपये प्रति वर्ष से अधिक नहीं होनी चाहिए।)
- The case of the **Kashmiri Migrant** will only be taken up subject to the submission of required certificate (**Kashmiri Migrant Certificate**) by the competent authority and confirmation from IGNOU HQs, New Delhi. (कश्मीरी प्रवासी का मामला केवल सक्षम प्राधिकारी द्वारा अपेक्षित प्रमाण पत्र प्रस्तुत करने तथा (कश्मीरी प्रवासी प्रमाण पत्र) इग्नूमुख्यालय, नई दिल्ली से पुष्टि के अधीन ही लिया जाएगा।)
